



**Disclaimer Form for PET Travel Scheme / Balai Directive on the Passenger Service**

On signing this form, I agree:

- that all relevant and necessary paperwork for the international transport of the(se) animal(s) has been completed and approved by the authorities concerned.
- to present, on request of Eurotunnel and/or the authorities concerned, all the necessary paperwork required for the transport in question.
- to have in my possession all relevant insurance documents required for the transport in question.
- that the animal(s) will stay within the vehicle during the crossing, even in the event of an incident, however serious it may be (even in the event of evacuation).
- that the containment of the animal(s) must be of such a nature that it will prevent physical contact of any kind between the animal(s) and any person(s) other than the person(s) in charge of the animal(s).
- that the section of the vehicle containing the animal(s) must be kept locked at all times whilst the vehicle is on the Concession and access restricted only to the person(s) in charge of the animal(s), for reasons of health and safety of these animal(s).
- that sufficient food and water is available to the animals during their journey with Eurotunnel (allowing for potential delays that may occur whilst on the Eurotunnel site).
- that the vehicle and its fittings are designed, constructed, and maintained to minimise urine and faeces leakage from flooring.

I also understand that the animal(s) cannot be evacuated from the wagon or the Shuttle under any circumstances during the crossing and that Eurotunnel accepts no liability or responsibility for the animals' welfare whilst on Eurotunnel's premises.

I also understand and agree that Eurotunnel will not be held liable if in the event that an animal suffers injuries or death, whatever the type of animal and its value.

I also understand that my booking details may be shared with the authorities i.e., Police, Animal Health and Trading Standards in accordance with Eurotunnel's Privacy Notice.
